Good afternoon, everyone. We're all here for the Henderson 215 stakeholder meeting #8. I'm Steve Conner, city engineer here at the City of Henderson and I'm in the room with Mr. Lance Olson.

So Kevie's going to go over the updates here like, like always. She'll go over current work that's happening, our future work and then we'll open up for questions. I'll turn it over to Kevie for our update.

Kevie Remynse 8:46

Good afternoon, everyone. Can we go to the next slide? Alright, so on the Beltway everyone probably saw the speed reduction just to make a safer space for everyone to travel. We also have the speed feedback signs, which you'll see over to the right to help drivers know exactly where they're at as far as speed.

Only 215. We continue on with the storm drain installation removals, and you've probably seen the retaining walls going up on both eastbound and westbound. Our current work hours are Monday through Friday daytime so 6am to 3pm, and then we also have some nighttime work ongoing right now that'll be 9pm to 6am Sunday night through Friday morning. During the day we currently have three lanes open in each direction. And at night we don't have any scheduled reductions at this time, but some may occur in the future. And our new lane configuration stays in place for a long duration.

One thing I wanted to add, Kevie, with the speed reductions is we were seeing some accidents inside of our work zone and we'd noticed that it was causing some major

delays where everyone's getting off, you know, the freeway there and getting back on. As you guys may have seen over the last month or so, so the project team got together and the most typical way of doing to lower the amount of crashes in a work zone is to reduce the speed limit. So, so far what we've seen, and I don't have any data to back this up, but just from our people on the project site is the reduced speed limit has reduced the crashes.

We haven't thankfully seen anything that's been significant since the speed reduction and then the speed feedback signs, you know, they don't always work as we like them because it's, you know, 3-4 lanes wide and it's reading too many vehicles. But what happens is when there is a less volume out there will read the vehicles pretty accurately and show people that they are they're speeding.

Alright, we do have some upcoming ramp closures as you can see on the screen they started this week. They'll continue on through next week and this is for mostly for the eastbound ramps. The dates are subject to change depending on the amount of work that is completed on those ramps overnight. Those closures will be in place from 9:00 PM to 6:00 AM. The message boards have been out for at least a week now. So, we will have the westbound ramp closures upcoming in probably the next month and we will have that on the website as well as in the e-mail when that comes out.

All right, so the I5, the I215 eastbound off ramp to Pecos, we are continuing to work on the storm drain installation. The work hours for that are 9:00 PM to 6:00 AM Sunday night through Friday morning. There are lane restrictions on the off ramps while that work continues.

For the westbound off ramp to Pecos. We continue that storm drain installation that I'm sorry, we'll begin that storm drain installation starting in mid-October. That again will be nighttime work. 9:00 PM to 6:00 AM Sunday night through Friday morning and there will be lane restrictions on the off ramps to allow for that work to safely be completed.

As you can see to the right, we. We have some central foundations.

Yeah. Barrier rail, we have some barrier rail being removed to allow for temporary shifts.

Yep, all right. So the surface streets, Green Valley Parkway from the Beltway between the Beltway and village Walk Dr. We will have potholing. That'll be the week of October 27th. Lane restrictions on Green Valley Parkway will be for a couple nights. And then it'll be open as it has been. At St. Rose Parkway and the Beltway, the traffic signal foundations are currently being worked on. That's happening overnight again. It's that 9pm to 6am schedule Sunday night through Friday morning. There are lane restrictions on St. Rose Parkway. There's a possibility for some daytime restrictions, but we are going to avoid those as much as we possibly can.

Paseo Verde Parkway at St. Rose, the crews are currently working on widening the right turn pocket. And again, that's the nighttime hours. 9pm to 6am Sunday night through Friday morning. There are lane restrictions on Paseo Verde and northbound St. Rose Parkway to allow for that work. So to the right, you can see the contractor is back filling around a newly placed traffic signal foundation due to the reconfiguration and widening of those areas for right hand turn.

All right, bike paths and trails, so the Beltway trail from Green Valley Parkway to Valley Verde. We're currently working on the storm drain installation that will be that's scheduled to be closed through late October. The Detour is to Paseo Verde Parkway.

The Beltway trail between Arroyo Grande to Stephanie Street. They're currently working on the retaining wall, which you can see in the picture to the right. That's what one of our walls being constructed looks like, and that's a long term closure. That detour again is to Paseo Verde and the bike path is closed on St. Rose Parkway between Coronado Center Drive and Paseo Verde drive. That is a long term closure.

So, I appreciate it. I mean driving at numerous times every day, the amount of earth moving and the amount of work being accomplished I think is pretty impressive and that you've able to, you've kept the three lines open each way is really a big deal and you probably don't hear that people appreciate that, but they do. So, I just wanted to say that.

of Earth movement out here, even like I don't know if you guys ever look at the south side of the 215, where there's that quad culvert that's being extended or reduced or whatever they're doing over there. You look at that hole. It's, I mean, it's massive, so. Appreciate the feedback. Any other questions from the group?
