Hi everyone. We'll give everyone about another minute or so, there's not that many people on the meeting right now, so we'll give it about a minute, and we'll get started.

Alright. We're about 3 after. We're just going to get started if people come in I'll answer their questions, if they have any. But welcome to you know Henderson, 215 stakeholder meeting #9. I'm Steven Conner city engineer, city of Henderson, and I have to my left.

Thanks guys. So we'll go over, you know, some updates with the project and then go over our holiday calendar once again. But Kevie's going to pretty much leave the meeting, so I'm going to turn it over to her and we'll get started on Slide 2.

# Kevie Remynse 10:08

Good afternoon. Alright so on the Beltway, from Pecos to Stephanie, we have the speed limit reduced to 55 mph. We also have speed feedback signs to try to assist drivers. We continue work on storm drain to install removals, retaining walls, sound walls. And we do have work hours from 9pm to 6am Sunday night through Friday morning, during the day we have three lanes opening each direction and in the nighttime, we're reducing lanes as needed.

So to the right, you'll see a picture. They're installing soil nail walls. This allows the retaining walls to be placed without a large removal of the material and affecting any of the improvements that are up above it. Right there. They're working on the

reinforcement for the shock replacement. And then after that, they'll place a form and concrete for that retaining wall.

All right. The 215 ramps. So 215 westbound off route to Pecos, we do continue to work on the storm drain installation in the overnight hours. This will continue on through late November. Our hours are 9pm to 6am Sunday night through Friday morning. And there are lane restrictions on the off ramp. Our upcoming overnight ramp closures for ramp realignment work are for the 215 eastbound, off ramp to Green Valley Parkway and those hours will be 9pm to 6am.

As you can see in the picture to the right, there was a sign removal that took place. Since we are widening the 215 that is that means that we're realigning the on and off ramps for each of the streets that we have within the project limits, from Stephanie to Pecos.

All right, for the surface streets on St. Rose Parkway at 215. The crews continue to work on the traffic signal installations in the overnight hours. There are lane restriction on Saint Rose Parkway and there is a possibility that in the future there will be some daytime restrictions as well. Paseo Verde Parkway at St. Rose Parkway. We are installing a right-hand turn pocket and again the majority of that work is at nighttime. We have had some daytime restrictions, for that area and the lane restrictions are on Paseo Verde Parkway and northbound St. Rose Parkway, and to the right you can see we're doing some underground utility work as well as the traffic signal work in the median island.

All right, our bike paths and trail closures. So the 215 trail from Green Valley Parkway to Valle Verde, we continue to work on the storm drain installation that is expected to be closed through early December. The detour is to Paseo Verde Parkway. For the 215 trail from Arroyo Grande to Stephanie, we are continuing to work on the retaining walls and that is a long-term closure. And again, the detour is Paseo Verde Parkway. There is a bike path closure on Saint Rose Parkway between Coronado Center and Paseo Verde, and that is a long-term closure. And again, those detour maps are on the website. If anyone's interested or wants a refresh on those.
